Provision of Gypsy Sites in the Royal Borough of Windsor and Maidenhead

We have had two Public Enquiries about Gypsy Sites in the Oakley Green and Fifield area in the past 3 years and 5 months:-

1) Brayfield Stables, Windsor Road, Water Oakley, Windsor.

2) Land rear of Skippets Lodge, Forest Green Road, Holyport, Maidenhead.

I was a Witness appearing on half of Bray Parish Council for the first Enquiry and an Observer for 2 days, representing our Community Association at the second Enquiry.

What was quite depressing was that the arguments used by the Barristers representing the Applicants on both occasions were substantially the same – even though the Enquiries were 3 years and 4 months apart. It looked like nothing had changed, and both Cases for the Appellants relied heavily upon the fact that RBWM had failed in their duty to provide enough Gypsy Sites and were causing harm to the affected Gypsy Families. The first Appeal was successful and in all likelihood, the second will also be allowed for the same reasons as before.

In the most recent Enquiry, RBWM relied heavily on their Plan that up to 10 Gypsy Pitches <u>may</u> become available in Datchet in September 2014, subject to the Secretary of State's Approval. And we have heard since that this may reduce to 9 given the provision of a Wardens Office.

But the RBWM Gypsy and Traveller Needs Assessment conducted in September 2012 and considered by Cabinet in January 2013, reported that 21 additional Pitches were needed in the period up to 2017 and a further 25 pitches in the medium to longer term, up to 2027.

However, in the second Enquiry we heard

- "Doubling up" of Gypsies on Sites is very common practice and thus constitutes an additional "Demand" which may not be recognised as, being an "illegal" practice, it is kept out of sight
- Existing Gypsy Sites have significant "Waiting Lists"
- RBWM is currently and has in the past pursued Enforcement Action on a number of Illegal Sites in the Borough
- The 4 year Temporary Permission for 2 Pitches at Brayfield Stables runs out on February 1, 2015
- All in all, the total current "Demand" now may be as much as 47 Pitches

In the past three years in Oakley Green and Fifield we have also seen Enforcement Action by RBWM in Oakley Green Road (Marshall Place) and just off the A308 (Water Oakley).

Failure to fix this ongoing problem of lack of Gypsy Site Provision is:-

- A huge drain on the stretched resources of the RBWM Planning Department reviewing Planning Applications for Gypsy Sites in the Green Belt, pursuing Enforcement Actions against Illegal Sites and preparing for and appearing at Public Enquiries.
- A Financial drain on RBWM employing very expensive external and specialist Agents and Lawyers pursuing Cases in the Courts for Enforcement Actions and against Appeals in Public Enquiries.
- A Financial drain on adjacent Landowners who are employing Agents and Lawyers to protect their interests in the Green Belt. (Bray Parish Council granted the Forest Green Landowners £5,000 in support of their Campaign which is estimated to have cost over £20,000).
- Creating much stress and frustration for Residents and Communities worried about illegal encampments and inappropriate development in the Green Belt.

RBWM is currently deeply involved in developing a Local Plan which is primarily focused on identifying potential Sites for Housing Development for the next 15 years. This effort is highly commendable and we have supported it fully. However, very worryingly, under Section 7.5 Gypsies, Travellers and Travelling Showpeople of the Preferred Options Document – it refers to Preferred Policy Option HOU 6. This says that only 7 Gypsy Pitches need to be provided in the period April 2012 to March 2017, 7 Pitches from 2017 to 2022, and 6 Pitches between 2022 to 2027 (20 in total). Yet another set of numbers and ones

which appear to wildly underestimate the real demand and in any case much less than what is in the Needs Assessment document of 2012.

During the Local Plan Consultation Events recently we have heard that RBWM know about every parcel of land which is potentially available for development.

Given the issues described above and the timing of the Local Plan:-

1). We urge RBWM to focus heavily and quickly on the Provision of Gypsy Sites as part of the important Local Plan exercise. Clearly the potential delivery of 10 (or 9?) Pitches in Datchet in September 2014 is not enough to satisfy immediate demand, and Preferred Policy Option HOU 6 is in no way appropriate and needs immediate revision.

2). We urge RBWM to target delivering

- 50 Gypsy Pitches as soon as possible granting Temporary Permission on Sites if necessary made up of
- 4 or 5 Sites of 10 to 15 Pitches so Cultural and Familial requirements of Gypsies can be accommodated

Delivering such a Target would solve what is becoming an increasingly expensive, problematic and frustrating situation across the Royal Borough.
